TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS - SPADRA LANDFILL AND RESOURCE CONSERVATION PROJECT, POMONA, LOS ANGELES COUNTY, CALIFORNIA (File No. 57-091)

Dear Mr. Maguin:

The Spadra Landfill and Resource Conservation Project (Landfill) in Pomona California, which has been closed since 2000, is currently regulated by Waste Discharge Requirements (WDRs) that were adopted by this Regional Water Quality Control Board (Regional Board) on January 23, 1989 (Order No. 89-006). In a letter dated December 8, 2008, the Regional Board Executive Office ordered the County Sanitation Districts of Los Angeles County (Discharger) to submit a revised Report of Waste Discharge (ROWD) to facilitate the revision of the WDRs to accurately reflect the current status of the site. On March 5, 2009, the Discharger submitted an updated ROWD to the Regional Board as required.

California Water Code, section 13263, provides that all WDRs shall be reviewed periodically and, upon such review, may be revised by the Regional Board to comply with changing state or federal laws, regulations, policies, or guidelines. Accordingly, Regional Board staff have prepared tentative revised WDRs for the Landfill. Enclosed are copies of the Tentative Requirements<sup>1</sup>, consisting of:

- a. Board Order
- b. Monitoring and Reporting Program (Attachment T)
- c. Definitions (Attachment A)
- d. US EPA Appendix II Constituents (Attachment B)
- e. Standard Provisions Applicable to Waste Discharge Requirements (Attachment W)

In accordance with administrative procedures, this Regional Board, at a public hearing to be held on April 1, 2010, at 9:00 AM, Metropolitan Water District of Southern California, 700 North Alameda Street, Board Room, in Los Angeles, California, will consider the enclosed tentative Order and comments submitted in writing regarding any or all portions thereof. The Regional Board will hear any testimony pertinent to this discharge and the tentative requirements. It is expected

that the Regional Board will take action at the hearing; however, as testimony indicates, the Regional Board at its discretion may order further investigation.

Written comments regarding the tentative Order must be received at the Regional Board office by the close of business on March 10, 2010, in order to be evaluated by Board staff and included in the Board's agenda folder. Submittal of written comments by the deadline is required to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised.
