**TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS AND MONITORING AND REPORTING PROGRAM FOR VENTURA COUNTY WATER AND SANITATION DEPARTMENT – TODD ROAD JAIL WASTEWATER TREATMENT PLANT AT 600 SOUTH TODD ROAD SANTA PAULA, CALIFORNIA (ORDER NO. R4-2024-XXXX, FILE NO. 91-076, CI-7418, GEOTRACKER GLOBAL ID WDR100001460)**

Dear David Fleisch:

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) is the public agency with primary responsibility for the protection of groundwater and surface water quality for all beneficial uses of water within major portions of Los Angeles and Ventura Counties, including the referenced property above.

On December 8, 2011, the Los Angeles Water Board adopted Waste Discharge Requirements (WDRs) Order No. R4-2011-0193 for the Todd Road Jail Wastewater Treatment Plant (Todd Road Jail WWTP) owned and operated by Ventura County Public Works – Water and Sanitation Department. Pursuant to the California Water Code (CWC) section 13263(e), all WDRs are reviewed periodically and upon such review, may be revised by the Los Angeles Water Board. Following a review of the Report of Waste Discharge, dated November 23, 2021, supplementary information dated April 22, 2022, and the existing requirements contained in WDRs Order No. R4-2011-0193, a tentative revised WDRs Order and monitoring and reporting program (MRP) have been prepared.

In accordance with administrative procedures, the Los Angeles Water Board is scheduled to consider the comments timely received on the enclosed tentative WDRs and MRP at a public hearing to be held at 9:00 a.m. on July 25, 2024, at 320 West 4th Street, Los Angeles, California, 90013 (Carmel Room). The Los Angeles Water Board will hear any testimony pertinent to this discharge and the tentative requirements. It is expected that the Los Angeles Water Board will take action at the hearing; however, as testimony indicates, the Los Angeles Water Board at its discretion may order further investigation.

In order to be evaluated by Los Angeles Water Board staff and included in the Los Angeles Water Board members' agenda packets, written comments or evidence regarding these tentative revised WDRs and MRP must be received at the Los Angeles Water Board's office by 5:00 p.m. on July 8, 2024. Failure to comply with these requirements is grounds for the Los Angeles Water Board to refuse to admit the proposed written comment or evidence into the record. Therefore, timely submittal of written comments is required to ensure that all comments are accurately and fully included in the administrative record, that Los Angeles Water Board staff is able to provide timely review and time to respond to comments, and that Los Angeles Water Board members have sufficient time to give full consideration to the comments and issues raised.

The agenda for the meeting will be posted on the Los Angeles Water Board's website ([https://www.waterboards.ca.gov/losangeles/board\\_info/agenda/](https://www.waterboards.ca.gov/losangeles/board_info/agenda/)) approximately 10 days prior to the meeting.
