#### **TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS AND MONITORING AND REPORTING PROGRAM FOR THE COUNTY OF VENTURA PUBLIC WORKS AGENCY – TODD ROAD JAIL WASTEWATER TREATMENT PLANT AT 600 SOUTH TODD ROAD, SANTA PAULA, CALIFORNIA (ORDER NO. The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public meeting to consider a tentative order revising Waste Discharge Requirements (WDRs) Order No. R4-2011-0193, which was previously adopted on December 8, 2011, for the discharge of treated domestic wastewater from the Todd Road Jail Wastewater Treatment Plant.
