POSTPONEMENT OF BOARD CONSIDERATION FOR ADOPTION OF REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT AND TIME SCHEDULE ORDER: CAMARILLO SANITARY DISTRICT WATER RECLAMATION PLANT (NPDES Permit No. CA0053597, CI # 1278)

Our letter dated August 12, 2008, informed you that revised tentative National Pollutant Discharge Elimination System (NPDES) permit and Time Schedule Order for the above subject facility would be heard during the September 11, 2008, Board Hearing, at the City of Simi Valley, Council Chambers, 2929 Tapo Canyon Road, Simi Valley. However, consideration of the revised tentative Orders has been postponed to a future Board Hearing.

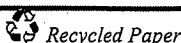
