NOTICE OF PUBLIC HEARING Public Notice No. 25-003

PROPOSED TERMINATION OF WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT

The Camrosa Water District (CWD) owns and operates the Camrosa Water Reclamation Facility (WRF), a publicly owned treatment works located at 1900 South Lewis Road, Camarillo, CA. The Camrosa WRF is a tertiary wastewater treatment plant that is currently permitted to discharge up to 2.25 million gallons per day (MGD) of tertiary-treated effluent from Discharge Point 001 (34.181389°, -119.028611°) to Calleguas Creek under Waste Discharge Requirements (WDRs) contained in Order No. R4-2020-0078, adopted by the California Regional Water Quality Control Board, Los Angeles Region (Los Angeles Water Board) on June 11, 2020. Order No. R4-2020-0078 also serves as a National Pollutant Discharge Elimination System (NPDES) permit (NPDES Permit No. CA0059501). CWD is also subject to WDRs and Water Reclamation Requirements WRRs) set forth in Order No. R4-2019-0118 to reuse the tertiary-treated effluent from the Camrosa WRF for crop and landscape irrigation.

In a letter dated January 27, 2025, the Discharger requested termination of coverage under NPDES Permit No. CA0059501 because (1) the Camrosa WRF has sufficient storage capacity for the effluent in its four offsite ponds with a total effluent storage capacity of 26 million gallons and can utilize the ponds as emergency storage for a holding time of approximately 20 days, (2) CWD has not discharged to Calleguas Creek since February 2005, and (3) the Camrosa WRF will discharge extra treated effluent not used for recycled water applications to the Calleguas Municipal Water District's Regional Salinity Management Pipeline.

On February 20, 2025, Los Angeles Water Board staff conducted a termination inspection for Order No. R4-2020-0078 and verified that the Discharge Point 001 conveying water from Pond No. 2 to Calleguas Creek, was capped. No other discharge points were observed, consistent with the NPDES permit.

Since there are several requirements included in NPDES Permit No. CA0059501 that CWD will need to continue to meet after the termination of the NPDES permit, this Termination Order is being adopted concurrently with an amendment to WDRs/WRRs Order No. R4-2019-0118. The amendment to the WDRs/WRRs incorporates additional requirements from NPDES Order No. R4-2020-0078, including requirements for sludge

disposal, best management practices and pollution prevention, a spill clean-up contingency plan, a climate change plan, spill reporting, construction, operation, and maintenance, and additional prohibitions. In addition to requirements from the NPDES permit, volumetric reporting requirements are also being incorporated in the amendment, consistent with State Water Resources Control Board Order No. WQ 2019-0037-EXEC. The Termination Order and the Amendment to Order No. R4-2019-0118 will be considered by the Los Angeles Water Board concurrently at the same Los Angeles Water Board hearing.

On the basis of preliminary staff review and application of lawful standards and regulations, the Los Angeles Water Board proposes to terminate Order No. R4-2020-0078.

Interested persons are invited to attend. At the public hearing, the Los Angeles Water Board will hear any testimony pertinent to the termination of the discharge, WDRs, and NPDES permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

hearing. The entire file will not be present in the hearing room. Should any interested persons desire staff to bring to the hearing any documents that are not included in the agenda packet, they must submit a written or electronic request to staff during business hours no later than five business days before the hearing. The request must identify the documents with enough specificity for staff to locate them.

NATURE OF HEARING

This will be a formal adjudicative hearing pursuant to section 648 et seq. of title 23 of the California Code of Regulations. Chapter 5 of the California Administrative Procedure Act (commencing with section 11500 of the Government Code) will not apply to this proceeding.

Ex Parte Communications Prohibited: As a quasi-adjudicative proceeding, no Los Angeles Water Board member may discuss the subject of this hearing with any person, except during the public hearing itself. Any communications to the Los Angeles Water Board must be directed to staff.

PUBLIC COMMENTS AND SUBMITTAL OF EVIDENCE

Persons wishing to comment on, or object to, the tentative termination of Order No. R4-2020-0078 or submit evidence for the Los Angeles Water Board to consider, are invited to submit them in writing to Don Tsai at Don.Tsai@waterboards.ca.gov. To be evaluated and responded to by the Los Angeles Water Board staff, included in the Los Angeles Water Board's agenda folder, and fully considered by the Los Angeles Water Board, written comments or testimony regarding the tentative documents must be received no later than **5:00 p.m. on May 16, 2025.**

Pursuant to section 648.4, title 23 of the California Code of Regulations, written comments or evidence submitted after the comment deadline will not be allowed or accepted into the Administrative Record without a showing of good cause for the delay, and in no event if any party or the Los Angeles Water Board would be unduly prejudiced by the late submittal including if staff or the Los Angeles Water Board would not have an adequate opportunity to review, consider, and respond to the comments or evidence.

Additionally, if the Los Angeles Water Board receives only supportive comments, the permit may be placed on the Los Angeles Water Board's consent calendar and approved without oral testimony.

HEARING PROCEDURE

The Los Angeles Water Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Los Angeles Water Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to five minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other. Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff not later than **June 12, 2025**, (two weeks prior to the hearing) to discuss how much time they believe is necessary for their presentations, and staff will endeavor to accommodate reasonable requests. At the conclusion of testimony, the Los Angeles Water Board will deliberate in open or closed session, and render a decision.

The Los Angeles Water Board meeting does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used during this hearing must be submitted in writing no later than close of business 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting on **July 24**, **2025**. A continuance will not extend any time set forth herein.
