The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff has revised the tentative WDRs and NPDES permit dated December 18, 2023, based on all comments received by the January 17, 2024 public comment deadline. Written comments are not being solicited regarding the revised tentative Order.
