REQUEST FOR COMMENTS ON THE TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRS) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT RENEWAL – KINDER MORGAN LIQUIDS TERMINALS LLC, CARSON TERMINAL (NPDES NO. CA0056863, CI NO. 5244)

We have completed our review of your application for a renewal of your permit to discharge waste under the National Pollutant Discharge Elimination System (NPDES) Program. Pursuant to the Federal Clean Water Act, as amended, and in accordance with the California Water Code, tentative waste discharge requirements have been prepared.

Lombard St. Ste. 200, Oxnard, CA 93030, will consider the enclosed tentative waste discharge requirements, and comments submitted in writing regarding any and all portions thereof. A virtual platform is also available for those who want to join online. Please follow the directions provided in the agenda to register or to view the Board meeting. The Los Angeles Water Board will hear any testimony pertinent to these waste discharge requirements. It is expected that the Los Angeles Water Board will take action at the hearing; however, as testimony indicates, the Los Angeles Water Board, at its discretion,

Written comments regarding this tentative Order must be received at the Los Angeles Water Board office by 5:00 p.m. on August 12, 2024, in order to be evaluated by Los Angeles Water Board staff and included in the Los Angeles Water Board's agenda folder. Comments received after that date will not be considered, absent extraordinary circumstances. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Los Angeles Water Board staff is able to provide timely review, and that Los Angeles Board members have sufficient time to give full consideration to the comments and issues raised. The Los Angeles Water Board chair may exclude from the record written materials received after this date. (See Cal. Code Regs., tit.23 § 648.4)

With respect to the public notices, in accordance with the Federal Clean Water Act, as amended, and the California Code of Regulations, the public notice will be posted on the Los Angeles Water Board's website
