TENTATIVE AMENDED WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR THE CITY OF LOS ANGELES, LOS ANGELES-GLENDALE WATER RECLAMATION PLANT (NPDES NO. CA0053953, CI NO. 5675)

The Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) staff have completed our review of your letter dated January 30, 2012, requesting that the Regional Water Board remove fecal monitoring requirements from the abovementioned NPDES permit. This request is triggered by the final approval of Regional Water Board Resolution No. R10-005, Amendment to the Water Quality Control Plan for the Los Angeles Region to Update the Bacteria Objectives for Freshwaters Designated for Water Contact Recreation by Removing the Fecal Coliform Objective. Resolution R10-005 became effective on December 5, 2011. This Resolution updates the freshwater bacteria objectives in the Basin Plan to maintain consistency with United States Environmental Protections Agency's recommendation that Escherichia Coli (E. coli) replace fecal coliform as an indicator of the presence of pathogens in fresh water, and removes unnecessary permitting and monitoring requirements that arise from having water quality objectives for both indicators. Regional Water Board staff completed the review and are proposing to revise the bacteria objectives and monitoring requirements presented in this tentative amended wastes discharge requirements.

Pursuant to the Federal Clean Water Act, as amended, and in accordance with the California Water Code, tentative waste discharge requirements have been prepared.

The Board will hear any testimony pertinent to this discharge and the tentative requirements. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff.

Written comments regarding this tentative Order must be received at the Regional Water Board office by 12 p.m. (noon) on May 31, 2012, in order to be evaluated by Board staff and included in the Board's agenda folder. Comments received after that date will not be considered, absent extraordinary circumstances. Timely submittal of written comments is required to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised.

The Regional Water Board is implementing a paperless office system to reduce paper use, increase efficiency, and provide a more effective way for our staff, the public and interested parties to view water quality documents. Therefore, convert all regulatory documents, submissions, data and correspondence that you would normally submit to us as hard copies to a searchable Portable Document Format (PDF). Documents that are 10 MB or larger should be transferred to a disk and mailed to the address listed above. With respect to the public notices, in accordance with the Federal Clean Water Act, as amended, and the California Code of Regulations, you are required to follow the enclosed instructions for publication or posting of the notice no later than **May 15, 2012**.

Failure to publish or post the notice by the above date may require us to reschedule this item for a later hearing and will require the publication or posting of a second notice. Please notify this Board by telephone when the notice has been published and submit the proof of publication or posting as required in the enclosed instructions. Proof of posting or publication of the notice must be received by the Executive Officer of this Regional Water Board no later than **May 31, 2012**.
