**NOTICE OF PUBLIC HEARING**

**PROPOSED REVISION  
OF  
WASTE DISCHARGE REQUIREMENTS  
(National Pollutant Discharge Elimination System Permit)**

The City of Los Angeles (hereinafter referred to as the City or Discharger) discharges tertiary-treated wastewater, from the Los Angeles-Glendale Water Reclamation Plant (Los Angeles-Glendale WRP) under Order No. R4-2011-0197 adopted by this Regional Board on December 8, 2011. Order No. R4-2011-0197 serves as a permit under the National Pollutant Discharge Elimination System (NPDES No. CA0053953). The NPDES Order is being amended to implement the Regional Water Board Resolution No. R10-005, *Amendment to the Water Quality Control Plan for the Los Angeles Region to Update the Bacteria Objectives for Freshwaters Designated for Water Contact Recreation by Removing the Fecal Coliform Objective*. Resolution R10-005 became effective on December 5, 2011. This resolution updates the freshwater bacteria objectives in the Basin Plan to maintain consistency with United States Environmental Protection Agency's recommendation that *Escherichia Coli* (*E. coli*) replace fecal coliform as an indicator of the presence of pathogens in fresh water, and removes unnecessary permitting and monitoring requirements that arise from having water quality objectives for both indicators.

The Discharger owns and operates the Los Angeles-Glendale WRP. The facility is located at 4600 Colorado Boulevard, Los Angeles, California, and treats wastewater generated from the Cities of Glendale, Burbank, Los Angeles, La Canada-Flintridge, and from Los Angeles Zoo. The Los Angeles-Glendale WRP is a tertiary wastewater treatment plant that treats municipal wastewater from domestic, commercial, and industrial sources. The facility is designed to treat 20 million gallons per day (mgd). The Los Angeles-Glendale WRP discharges the treated wastewater to the Los Angeles River, a water of the United States, at a point located approximately 1,400 feet downstream of Colorado Boulevard (latitude 34°08'25", longitude 118°17'24"), in the Los Angeles River Narrows, above the river Estuary.

On the basis of preliminary staff review and application of lawful standards and regulations, the California Regional Water Quality Control Board, Los Angeles Region, tentatively proposes to issue revisions to the Discharger's waste discharge requirements, including effluent limitations and special conditions.

#### PUBLIC HEARING DATE AND LOCATION

The Regional Water Board will hold a public hearing on the tentative WDRs during its regular Board meeting on the following date and time and at the following location:

Interested persons are invited to attend. At the public hearing, the Regional Water Board will hear testimony, if any, pertinent to the discharge, WDRs, and permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

#### AVAILABILITY OF DOCUMENTS

The Report of Waste Discharge (ROWD), the settlement agreement, other documents relied upon, tentative effluent limitations and special provisions, comments received, and other information are on file and are available for inspection and copying between the hours of 8:00 a.m. and 4:30 p.m. by appointment at the following address:

The entire file will become a part of the administrative record of this proceeding, irrespective of whether individual documents are specifically referenced during the hearing or contained in the agenda packet. The entire file will not be present in the hearing room. In addition to the materials generated for this proceeding, the file includes the administrative records for the applicable Basin Plan amendments. Should any interested persons desire staff to bring to the hearing any particular documents that are not included in the agenda packet, they must submit a written or electronic request to staff during business hours, not later than five business days before the hearing. The request must identify the documents with enough specificity for staff to locate them.

#### PUBLIC COMMENTS AND SUBMITTAL OF EVIDENCE

Persons wishing to comment on, or object to, the tentative waste discharge requirements, or submit evidence for the Board to consider, are invited to submit them in writing to Raul Medina

To be evaluated and responded to by Regional Water Board staff, included in the Board's agenda folder, and fully considered by the Board, written comments or testimony regarding the tentative must be received no later than **12 p.m. (Noon) on May 31, 2012**. Failure to comply with these requirements is grounds for the Regional Water Board to refuse to admit the proposed written comment or exhibit into evidence pursuant to section 648.4, title 23 of the California Code of Regulations.

### NATURE OF HEARING

This proceeding will be a formal adjudicatory proceeding. For such proceedings, the Regional Water Board follows procedures established by the State Water Resources Control Board. These procedures are set forth in regulations commencing with section 647 of title 23 of the California Code of Regulations, in particular, Article 2, commencing with section 648.

### PARTIES TO THE HEARING

The following are the parties to this proceeding:

- City of Los Angeles/permittee

Any other persons requesting party status must submit a written or electronic request to staff not later than 20 business days before the hearing. All parties will be notified if other persons are so designated.

### HEARING PROCEDURE

The Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to five minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other. Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff not later than June 28, 2012, (two weeks prior to the hearing) to discuss how much time they believe is necessary for their presentations, and staff will endeavor to accommodate reasonable requests. At the conclusion of testimony, the Board will deliberate in open or close session, and render a decision.

The Board does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used

during this hearing must be submitted in writing no later than close of business 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting in September 6, 2012. A continuance will not extend any time set forth herein.
