Comments received after that date will not be considered, absent extraordinary circumstances. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Los Angeles Water Board staff is able to provide timely review, and that the Los Angeles Water Board members have sufficient time to give full consideration to the comments and issues raised. The Los Angeles Water Board chair may exclude from the record written materials received after this date (see Cal Code Regs., tit. 23 § 648.4).
