TERMINATION OF WASTE DISCHARGE REQUIREMENTS FOR SURFACE IMPOUNDMENT – HALACO ENGINEERING CO., 6200 PERKINS ROAD, OXNARD, CALIFORNIA (FILE NO. 70-024, GEOTRACKER ID SL0611114905)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will consider termination of Waste Discharge Requirements (WDRs) Order No. 80-058, adopted by the Los Angeles Water Board on October 27, 1980, for the Halaco Engineering Company (Discharger) metal recycling facility located at 6200 Perkins Road, Oxnard, California.

submittal including if staff or the Los Angeles Water Board would not have an adequate opportunity to review, consider, and respond to the comments or evidence.
