**POSTPONEMENT OF PUBLIC HEARING REGARDING TERMINATION OF INDIVIDUAL WATER RECLAMATION REQUIREMENTS ORDER NO. 97-071 FOR THE TOP O'TOPANGA COMMUNITY ASSOCIATION WASTEWATER TREATMENT PLANT LOCATED AT 3360 NORTH TOPANGA CANYON BOULEVARD, TOPANGA, CALIFORNIA 90290 (FILE NO. 61-149, CI-3185 GLOBAL ID WDR100000744)**

Dear Ken Solomon:

On May 21, 2025, the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) released a tentative Order for public review, proposing the termination of Water Reclamation Requirements (WRRs) Order No. 97-071 for the Top O'Topanga Community Association (Association) Wastewater Treatment Plant (Facility).

However, on May 28, 2025, coverage under the General Waste Discharge Requirements (WDRs) Order No. R4-2019-0024 (Series No. 066) was rescinded because the Association is currently unable to meet all applicable requirements of the General WDRs due to limitations in its existing treatment capabilities and ongoing considerations related to potential Facility upgrades. As a result, enrollment under the General WDRs has been deferred until further information becomes available regarding the planned improvements.

Consequently, WRRs Order No. 97-071 will remain in effect, and the public hearing previously scheduled for June 26, 2025, has been postponed. The Los Angeles Water Board will issue a future notice once it is appropriate to move forward with the termination of WRRs Order No. 97-071.
