ZOOM ONLINE WORKSHOP

2022 ADOPTED STORMWATER CONSTRUCTION GENERAL PERMIT REISSUANCE (Order WQ 2022-0057-DWQ, NPDES NO. CAS000002)

IT IS HEREBY ORDERED that this Order supersedes Order 2009-0009-DWQ as amended by Order 2010-0014-DWQ and 2012-0006-DWQ except for: (1) the requirement to submit annual reports by September 1, 2023, (2) enforcement purposes, and (3) as set forth in Section III.C of this Order. The discharger shall comply with the requirements in this Order to meet the provisions contained in Division 7 of the California Water Code (commencing with § 13000) and regulations adopted thereunder, and the provisions of the federal Clean Water Act and regulations and guidelines adopted thereunder.

IT IS ALSO HEREBY ORDERED that on or after December 17, 2022, a discharger deploying Executive Order N-73-20 may obtain regulatory coverage through the statewide programmatic permitting option in Section III.B.4 under Order 2009-0009-DWQ as amended by Orders 2010-0014-DWQ and 2012-0006-DWQ until September 1, 2023.

PURPOSE OF THE WORKSHOP:

This workshop is intended to assist the Los Angeles Regional Water Quality Control Board (Region 4) permittees, environmental professionals, and local agencies in their implementation of the updated requirements of the Reissued Stormwater Construction General Permit (Reissued CGP) that was adopted on September 8, 2022 (Order WQ 2022-0057-DWQ). This workshop will focus on the new requirements in the Reissued CGP as they relate to Region 4, and is not meant to contain a comprehensive information on how to comply with the Reissued CGP in its entirety. Topics include:

- Statewide Water Quality Control Plan / Ocean Plan Exemption
- Pollutant Source Assessment

- Passive Treatment Technology & Active Treatment System
- Authorized Dewatering Activity
- Demolition Activity

- Notice of Non-Applicability
- Regulatory Transition Period & Notice of Intent Recertification
- New SWPPP, TMDL-Related BMP Implementation, & Other Requirements
- Risk Calculation Revision
- Notice of Termination & Post-Construction Requirements
- Coverage Revision
- Change of Information
- TMDL-Related Compliance Option (Pesticides / PCBs / OCPs)
