## Remediation Sections I and II

### **Update on the Former Kast Property Tank Farm, Carousel Tract Residential Neighborhood, Carson**

Activities related to site investigation and cleanup work performed in February 2025 include the following:

1. On February 11, 2025, the Los Angeles Water Board received a document titled *Fourth Quarter 2024 Remediation Progress Report* for the former Kast Property Tank Farm. The report summarizes activities related to the remediation conducted from October to December 2024, such as monitoring of groundwater, light non-aqueous phase liquid (LNAPL) recovery and sub-slab soil vapor probe sampling; the outreach conducted with residents; and the operation and maintenance of the soil vapor extraction (SVE) system.
2. On February 18, 2025, monthly light nonaqueous phase liquid (LNAPL) removal was conducted by Shell from monitoring wells MW-03, MW-12, and MW-18 at the Carousel Tract.
3. On February 27, 2025, the Los Angeles Water Board received documents titled *Sub-Slab Soil Vapor Monitoring Reports* for four properties located within the former Kast Property: 24433 Marbella Avenue, 24513 Ravenna Avenue, 24712 Neptune Avenue, and 24722 Neptune Avenue. The reports summarize sub-slab soil vapor monitoring of volatile organic compounds and fixed gases at the four properties in accordance with the 2014 Revised Remedial Action Plan.
4. To date the cleanup of 285 (100 %) properties/homes have been completed.

### **Former Athens Tank Farm / Ujima Village Apartments and Ervin Magic Johnson Regional Park (EMJRP), Los Angeles**

Activities related to the environmental site investigation of the Former Athens Tank Farm conducted in February 2025 are summarized below:

1. On February 21, 2025, Los Angeles Water Board staff received a voice message from a Willowbrook resident who lives adjacent to Earvin Magic Johnson Park. The resident was inquiring about some recent field activity by Kleinfelder field staff near her residence. Los Angeles Water Board staff called Kleinfelder and determined that they were performing routine LNAPL measurements and removal (bailing) of some nearby wells. Los Angeles Water Board staff emailed DTSC public participation staff and informed the project team of this recent inquiry. DTSC staff is following up with the resident to coordinate a call with Los Angeles Water Board and DTSC.
2. Recent and ongoing activities for the former Athens Tank Farm site are as follows:  
  
Ongoing weekly Phase I/II remediation systems operation & maintenance (O&M).

Phase III Remediation Systems:

- a. Groundwater monitoring wells ATF-10A (shallow) and ATF-10B (deep) continued to be inaccessible during February 2025 due to the placement of fencing by the Ujima Housing Corporation (UHC). Access to these wells is currently being negotiated with the UHC. These wells will be monitored and sampled during the next monitoring event following an access agreement. Kleinfelder will reach out to UHC staff to try resolving this matter and may request assistance from the Los Angeles Regional Board to facilitate access.
- b. Weekly Phase III remediation systems O&M activities are ongoing.

#### NAPL Recovery Trailer

- a. The NAPL Recovery Trailer was fully operational throughout February 2025.
- b. The NAPL Recovery Trailer has been and continues to operate primarily on wells ATF-19B and ATF-21B; and
- c. Attempted NAPL pneumatic recovery in well ATF-13B using low-flow rate
  - Results showed NAPL recovery similar to that of manual bailing due to slow recharge of NAPL into well ATF-13B (see Tier II info below)
- d. The NAPL Trailer was positioned over the well ATF-21B in February 2025.
  - NAPL Tier I cumulative recovery as of August 31, 2024, using NAPL Recovery Trailer was 6,156 gallons (593 gallons in 4<sup>th</sup> Qtr. 2024)
- e. NAPL Tier II manual bailing in February 2025 was conducted primarily on groundwater monitoring wells ATF-13B and ATF-19B; and
  - NAPL Tier II cumulative recovery as of November 30, 2024, with manual bailing methods was 579.9 gallons (102.7 gallons in 4<sup>th</sup> Qtr. 2024);
- f. NAPL Tier III recovery (oleophilic absorbent socks) is currently deployed in 11 wells: ATF-5B, ATF-10A, ATF-22B, ATF-26B, ATF-28B, ATF-29B; KLFOB-01, KLFOB-02; KLFSVE-01, KLFSVE-02 and KLFSVE-03.
  - A total of 5 absorbent socks were replaced in the fourth quarter of 2024. The socks were replaced in ATF-5B, ATF-22B, ATF-28B and ATF-29B.
  - A cumulative total of 162 absorbent socks have been replaced as of November 30, 2024 (5 socks replaced during the 4<sup>th</sup> Quarter 2024).
- g. Cumulative NAPL (Tier I and II) through August 31, 2024, was 6,040 gallons.

#### Air/Bio-Sparge System

1. The Los Angeles Water Board approved the Phase III Air Sparge System Shutdown Request on January 12, 2024. Therefore, the air sparge/bio-sparge system was non-operational during February 2025. All Phase III Air Sparge System equipment, piping and wells will remain onsite for future use if necessary pursuant to the Los Angeles Water Board's letter.
2. As of November 30, 2024, the cumulative estimated mass of VOCs removed using the Phase III air sparge/bio-sparge system was 250,842 pounds.

### *Commercial, Industrial, and Institutional (CII) Stormwater Program Update*

On November 2, 2023, the CII Unit staff finalized and released for public review the Los Angeles Water Board's responses to 33 written public comments received and subsequently revised tentative General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements (CII Permit) for certain CII Facilities in the Dominguez Channel/Inner and Outer Los Angeles and Long Beach Harbor Watershed and the Los Cerritos Channel/Alamitos Bay Watershed.

USEPA released its final designation memo on November 20, 2024. A newly revised tentative CII Permit conforming to the final designation will be proposed for adoption consideration at an upcoming board meeting.

Staff continued to develop the Stormwater Multiple Application and Report Tracking System (SMARTS) for the CII Permit online database. The SMARTS workgroup, which includes staff from the CII Unit, the State Water Board Department of Water Quality and Division of Information Technology (DIT), and DIT's contractors, meets bi-weekly to refine the SMARTS development and ensure the database to be functional upon the adoption of the revised CII permit.

### *SB 1215 Program Update*

Senate Bill 1215 (SB 1215) Wastewater Consolidation (WWC) Program staff (staff) continue to work closely with the State Water Board Division of Financial Assistance (DFA), public sewer service providers, and technical assistance (TA) providers, Rural Community Assistance Corporation and Moonshot Missions, to implement the WWC Program in the priority disadvantaged/severely disadvantaged communities (DACs/SDACs) within Region 4. The following are program related activities in February 2025.

On February 28, 2025, staff completed the review of the draft Plans of Study for the West of North Ventura Avenue and East Casitas Springs projects. The review included an examination of project details, Ojai Valley Sanitary District's (OVSD) proposed Scope of Work, including the Planning and Design Cost Estimates, and the Planning and Design Deliverable Schedule to ensure consistency across tasks. The documents are being prepared for transmittal to OVSD for its revisions and submittal to DFA for getting on the Clean Water State Revolving Fund Fundable List.

## Watershed Regulatory Section

On February 18, 2025, the Las Virgenes Municipal Water District commenced a tracer study at the Westlake Reservoir, located south of Westlake Village. The tracer study deployed rhodamine WT tracer, an NSF/ANSI 60 certified fluorescent dye that is routinely used to measure stream flows and other water bodies, to measure and track the movement of waters within the reservoir. The data captured from this study will be used to calibrate the mixing model for the upcoming Las Virgenes Pure Water Project. The tracer study is expected to last for approximately 45 days, at which time the Westlake Filtration Plant will not be drawing water from the reservoir. Operation of the Westlake Filtration Plant will resume once the concentration of rhodamine WT has sufficiently degraded.
