### Board Member Méndez reported on the following:

In October 2024, Board Member Méndez attended the California Safe Schools panel. The NGO promotes environmental stewardship in public schools, particularly in the LAUSD. He was a panelist along with the newly appointed DTSC Director, Katherine Butler.

Board Member Méndez was recently appointed to the Public Policy Institute of California which is one of California's premier nonpartisans think tanks.

### Vice Chair Nahai reported on the following:

Vice Chair Nahai was honored by Governor Newsom's decision to reappoint him to the Los Angeles Regional Water Quality Control Board (LARWQCB). The next step of his reappointment is the Senate confirmation.

On November 13, 2024, Vice Chair Nahai, Chair Camacho, Executive Officer Susana Arredondo, and Assistant Executive Officer Jenny Newman toured the

AES Alamitos facility in Long Beach.

## Chair Camacho reported on the following:

Chair Camacho mentioned that she toured the AES Alamitos facility in Long Beach.

On November 13, 2024, and December 11, 2024, Chair Camacho attended Safe Clean Water, Regional Oversight Committee (ROC) meetings. The water quality working group is continuing to make progress to outline water quality targets for the many watershed areas. The next ROC meeting will be held in January 2025.

## Item 5 – Executive Officer's Report

The EO provided updates of the following items:

- On October 18, 2024, the LARWQCB approved a settlement over 1.6 million dollars with the City of Los Angeles and the Los Angeles Sanitation & Environment. The settlement resolved a 1.7-million-gallon sewage spill into the Los Angeles River that prompted local officials to close multiple beaches.
- On October 25, 2024, the LARWQCB approved a \$201,000 dollar settlement with the Long Beach Generating Station for effluent limit exceedances to its National Pollutant Discharge Elimination System Permit.
- On Sunday, November 17, 2024, Susana Lagudis, the LARWQCB's Public Participation, Environmental Justice, and Tribal Coordinator and Susana Arredondo, Executive Officer attended a dedication and plaque unveiling ceremony honoring the late Chief Ernie Salas of the Kizh/Gabrielino Band of Mission Indians.

*Chair Camacho opened the floor for Board members' comments and questions.* There were no comments or questions from the Board members.

## Item 6 – Update from State Water Board [Board Member Laurel Firestone]

Board Member Firestone provided an update of the following items:

- December 16, 2024, marked the 50th anniversary of the Safe Drinking Water Act (SDWA).
- On January 23, 2025, the State Water Board is scheduled to hold a workshop discussing the San Francisco Bay/Sacramento-San Joaquin Delta Watershed proposed update.
- The January 7, 2025, SGMA Probationary hearing for the proposed designation of the Kaweah Subbasin is cancelled.
- The Kern County Subbasin probationary hearing is scheduled for February 20, 2025.
- On December 9, 2024, the State Water Board held a workshop on the Mill, Deer, and Antelope Creeks.
- The Safe and Affordable Funding for Equity and Resilience (SAFER) Advisory Group held its last meeting of 2024 on December 5, 2024. New advisory group

members were appointed.

 On November 6, 2025, State Water Board held a workshop on the Clean Water State Revolving Fund (CWSRF) and Drinking Water State Revolving Fund (DWSRF) proposed amendments.

Chair Camacho opened the floor for Board members' comments and questions.

Board Member Méndez, Vice Chair Nahai and Chair Camacho made comments and asked questions. Board Member Firestone responded to their comments and questions.
