The State Water Resources Control Board (State Water Board) submitted this action for review under Government Code section 11353 to adopt section 3939.49 in title 23 of the California Code of Regulations that adds a concise summary of an amendment to the Water Quality Control Plan for the Los Angeles Region (Basin Plan). The Basin Plan amendment was adopted by the Los Angeles Regional Water Quality Control Board on February 12, 2015 in Resolution No. R15-001. The State Water Board approved the Basin Plan amendment on July 21, 2015 in Resolution No. 2015-0048. The Basin Plan amendment incorporates stakeholder-developed, voluntary groundwater quality management measures for salts and nutrients in the Central and West Coast basins.

OAL approves this regulatory action pursuant to section 11353 of the Government Code.
