Dear Mr. Reimers:

I am in receipt of Chris Andrian's letter of October 9, 2024, requesting an extension to the deadline for implementing the Restoration Mitigation and Monitoring Plan (RMMP) and providing justification for that request. I understand that on October 15, 2024, Regional Water Board staff (Staff) met onsite with you and members of your team to observe the work that has been accomplished to date. I also understand that Staff provided recommendations for winterizing the site, and that your team has subsequently provided photos to demonstrate winterization efforts.

Stipulated Order No. R1-2023-0045 incorporated a settlement agreement that granted an extension for implementation of a RMMP until October 15, 2023. On October 17, 2023, I extended the deadline to implement the RMMP to October 15, 2024, following a request last year.

By this letter, I hereby modify Cleanup and Abatement Order No. R1-2019-0045 Directive No. 9 and approve the requested extension of the deadline to fully implement and complete the RMMP to October 15, 2025.
