Lauren Clyde, Regional Water Board staff, updated the Board on staff's efforts in evaluating the most effective way to implement the requirements of the State Water Board's Recycled Water Policy. Staff proposed to adopt an action plan to address the key aspects of the requirements of the Recycled Water Policy as part of a Basin Plan Amendment that is currently underway. Chairman Geoff Hales stated that he will send a letter to the Chair of the State Water Board seeking concurrence with the Regional Board's staff proposed approach.

The site was a former manufacturing plant for pressed board products, including siding, door facing, and indoor paneling. She described the operations of the plant, the patterns of chemical use at the plant, and the status of the soil and groundwater contamination, investigation, and cleanup.
