The North Coast Regional Water Quality Control Board (Regional Water Board or Board) proposes to adopt Rescission of Waste Discharge Requirements Order No. R1-2019-0007 for the Airport-Larkfield-Wikiup Sanitation Zone and Sonoma County Water Agency, Airport-Larkfield-Wikiup Sanitation Zone Wastewater Treatment and Reclamation Facility (Facility).

Public Hearing Procedures

A public hearing to consider adoption of a proposed Recission Order is scheduled for the Regional Water Board's **February 18 & 19, 2026** Board Meeting, or as announced in the Regional Water Board's agenda. This public meeting is currently scheduled to take place in-person and via video and teleconference in Del Norte County (hearing location to be determined), but the format may be changed in the future. In order for the Regional Water Board to consider any written evidentiary material concerning this hearing, any documents, including written technical reports and other evidentiary material, must be submitted to the Regional Water Board email at NorthCoast@waterboards.ca.gov *attention: Tina Low*, **no later than 5:00 pm, on December 10, 2025**. All documents that are received timely will be distributed to the Regional Water Board members and interested persons. These records will also become a permanent part of the administrative record for this public hearing.

Except at the discretion of the Regional Water Board Chair, written material received after the above date will not be accepted. If the Chair chooses to accept late written evidentiary material, that material will not be incorporated into the administrative record if doing so would prejudice any party or the Board. The Chair may choose to modify this rule upon a showing of severe hardship (California Code of Regulations, Title 23, sections 648.1 and 648.4).

Oral comments will also be accepted at this hearing. Oral comments or testimony at the hearing may summarize or explain timely submitted, or late-accepted written evidence, or present policy statements. The time limit for oral comments will be set by the Regional Water Board Chair and are subject to change. These time limits normally allow 20 minutes each for Regional Water Board staff and Dischargers. Interested persons are generally limited to five minutes. These limits may be modified by the Chair upon request and at the Chair's discretion.
