# Notice of Proposed No Further Action

A soil and groundwater investigation conducted at the referenced site discovered a release of petroleum hydrocarbons. Although some contamination remains, this site meets the conditions for closure under the State Water Resources Control Board's Resolution 92-49. Regional Water Board staff proposes that no further work be required. The purpose of this notice is to inform interested parties, including owners of nearby land, that the case is being considered for closure, and to invite public comment on this proposed decision.

### **Problem Description**

The Zanzi Property is zoned as commercial and is currently a vacant lot with no buildings present. There was an above ground coal oil storage tank (AST) on the property that was removed between 2005 and 2009. A 2013 Phase I and Phase II environmental site assessment found petroleum hydrocarbons in the diesel range (TPHd) and some metals, including lead, nickel, and zinc in the soil and TPHd in groundwater at one location. The TPHd was above maximum contamination levels (MCL) for industrial standards for soil and groundwater however the metals were below the MCLs. A 2023 soil and groundwater investigation found that current impacts were small and limited to approximately 40 feet around the former AST and machinery storage areas. Contamination in groundwater was only found in the immediate vicinity of the site, and is no longer spreading. No water supply wells were impacted by this contamination.

#### **Proposed Action**
