REVISED NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT, BOARD WORKSHOP, AND BOARD HEARING

Proposed General Order for Waste Discharge Requirements for Commercial Vineyards in the North Coast Region and Draft Environmental Impact Report

NOTICE IS HEREBY GIVEN of an extension of acceptance of written comments by the California Regional Water Quality Control Board, North Coast Region (Regional Water Board), on the proposed General Waste Discharge Requirements for Commercial Vineyards in the North Coast Region (proposed General Order) and supporting California Environmental Quality Act (CEQA) draft Environmental Impact Report (EIR).

NOTICE IS ADDITIONALLY HEREBY GIVEN that the Regional Water Board will hold a public workshop on the proposed General Order and supporting draft EIR. Board members will be present, however less than a quorum of the Board will be in attendance and the Board will not take any action at the public workshop.

The public workshop is scheduled for August 4th, 2023, at 9:00 a.m. in the Regional Water Board Hearing Room, 5550 Skylane Blvd, Suite A, in Santa Rosa, California. This meeting is scheduled to occur with both a physical meeting location and an option for remote participation via video and teleconference. Live video and audio broadcasts of the public workshop will be available via the internet and can be accessed at the CalEPA Public meeting live webcasts webpage (https://video.calepa.ca.gov). The public workshop will be recorded.

NOTICE IS ADDITIONALLY HEREBY GIVEN that the Regional Water Board will conduct a public hearing to consider adoption of the proposed General Order and EIR.

The public hearing is scheduled for December 12th or 13th, at 9:00 a.m. in the Regional Water Board Hearing Room, 5550 Skylane Blvd, Suite A, in Santa Rosa, California. This meeting is scheduled to occur with both a physical meeting location and an option for remote participation via video and teleconference. Live video and audio broadcasts of the public workshop will be available via the internet and can be accessed at the CalEPA Public meeting live webcasts webpage (https://video.calepa.ca.gov). The meeting will be recorded.

Please be aware that dates and venues may change. In accordance with the Bagley-Keene Open Meeting Act (Gov. Overview

There are approximately 65,000 acres of land planted to vineyards in the North Coast Region. Over 95% of North Coast vineyards are located within the Navarro and Russian River watersheds which are impaired for sediment and temperature and provide habitat for threatened and endangered salmonid species. Cultivation of winegrapes has the potential to discharge wastes to surface waters and groundwater (through soil disturbance and use of agricultural chemicals) and affect other related controllable water quality factors such as the loss of riparian shade. The Regional Water Board has a statutory obligation under the Federal Clean Water Act and the State Porter-Cologne Water Quality Control Act to regulate discharges of waste to waters of the state, restore water quality in impaired waters, and maintain existing high-quality waters.

The proposed General Order would regulate the cumulative impacts of commercial vineyards through requirements, prohibitions, and provisions applied to farmed areas and appurtenant road networks. Under the proposed General Order, growers would be required to self-assess the conditions on their vineyard and report implementation of minimum management practices and nitrogen use. The proposed General Order would also require surface and groundwater quality monitoring and adaptive management in response to monitoring. The proposed General Order would allow the option for growers to enroll in third-party programs which assist with enrollment, fee collection, monitoring, reporting, and grower education.

Public Comments

Any written comments regarding the proposed General Order must be submitted and received by the Regional Water Board by 5:00 p.m. on August 30, 2023. Electronically submitted comments in pdf text format (if less than 15 megabytes in total size) can be sent to NorthCoast@waterboards.ca.gov. If the file is greater than 15 megabytes in total size, then the comment letter may be submitted by fax at (707) 523-0135 or mailed to Agricultural Lands Program, 5550 Skylane Blvd, Ste. A, Santa Rosa, CA 95403. Written comments received after the above date will not be accepted, except at the discretion of the Regional Water Board Chair.

Staff request that comments on the proposed General Order be submitted with the subject line "Comments on Draft Vineyard Order," and any comments on the supporting Draft EIR be submitted separately with the subject line "Comments on Draft EIR for Vineyards".

Oral comments will also be accepted at the workshop and hearing. The time limit for oral comments will be 5 minutes; however, additional time may be provided, upon request. A timer may be used, and speakers are expected to honor time limits. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson to avoid unnecessary or repetitive presentations.

Procedural Matters

The Regional Water Board will not consider certification of the EIR or adoption of the proposed General Order at the public workshop. The Regional Water Board will consider certification of the EIR and adoption of proposed Vineyard Order at the December Board meeting. The procedures governing Regional Water Board hearings may be found in the California Code of Regulations, title 23, section 648 et seq. and are available upon request.

Ex parte communications are allowed in this matter subject to the disclosure requirements of Water Code section 13287,

Any communications between interested persons and board members (other than at a noticed board meeting or workshop where the Vineyard Order is on the agenda or submitted as a comment letter in compliance with this or another public notice) must be disclosed by the interested person within seven working days of the communication.
