Program Purpose

- Regulatory program to meet and maintain water quality standards
- Protect beneficial uses of waters of the state
- Regulate discharges of waste associated with irrigated lands
- Comply with Federal and State law
 - Implement TMDLs and address impaired waters listings
 - Meet State Nonpoint Source Policy
 - Protect high quality waters

Mission Statement

"Mission is to preserve, enhance and restore the quality of California's water resources."

Total Maximum Daily Loads

- Regional Board implements Clean Water Act in California
- Clean Water Act requires TMDLs for impaired waters – in most cases
- State of California requires TMDL implementation plans
- Klamath TMDL directs Regional Board to develop permits for irrigated agriculture and grazing by 2012 in the Klamath Basin

State Nonpoint Source Policy

- State Nonpoint Source Policy (2004)
- Directs Regional Boards to adopt a combination of the following for all nonpoint source pollution
 - Waste Discharge Requirement (WDRs)
 - Conditional Waivers
 - Prohibitions
- Examples of nonpoint pollution sources
 - Roads
 - Agriculture
 - Timber Harvest
- Applies to surface waters and groundwaters

Meeting Federal and State Law

- Requirements are similar
 - 1. Actions(management practices) to achieve water quality goals
 - 2. Time Schedule
 - 3. Monitoring and Reporting
 - 4. Compliance
- Same management practices used for TMDL implementation and NPS Program
- Regional Board has incorporated TMDL requirements into regionwide NPS programs
- More efficient and avoids overlapping programs

Porter Cologne Water Quality Control Act of 1969

- California Water Code sections 13000 14958
- Establishes State Water Resources Control Board and 9 'Regional' Water Quality Boards
- Authority to establish regional 'Basin Plans' that designate beneficial uses of the state's waters and water quality objectives
- Irrigated Lands Discharge Program intended to implement the Basin Plan

Water Quality Objectives and Beneficial Uses

- Sensitive Beneficial Uses
 - Uses related to cold water aquatic species
 - Drinking water
 - Recreation
- Relevant Water Quality Objectives
 - Temperature
 - Sediment
 - Bacteria/Pathogens
 - Biostimulatory Substances (Nutrients)
 - Toxics

13263 Waste Discharge Requirements (WDRs)

- Any person discharging waste to surface or ground waters must file a Report of Waste Discharge unless waived (Section 13260)
- WDRs prescribe requirements regarding the nature of the discharge taking into consideration
 - 1. the protection of beneficial uses
 - 2. any relevant water quality objectives
 - 3. the conditions of the receiving water
- The Board can also adopt General WDRs for similar types of discharges

13269 - Conditional Waivers

- Waives requirement to submit a report of waste discharge if conditions are met
- Board can also adopt general waivers

13243- Prohibitions

- Adopted into the Basin Plan or put into a permit
- Prohibit certain types of discharges
- Can be conditional and operate as a nonpoint source program

Enforcement

- Porter-Cologne Act provides enforcement tools
- State Enforcement Policy directs Regional Boards' approach
 - Fair, firm, consistent
 - Progressive enforcement


