### Third “My Water Quality” Internet Portal Evaluates Quantity and Quality of California’s Wetlands

**Sacramento**— The California Water Quality Monitoring Council (Monitoring Council) is unveiling the third My Water Quality internet portal to connect decision makers and the public with water quality information. The theme of this new portal is “*Are Our Wetland Ecosystems Healthy?*” View the new portal at [www.waterboards.ca.gov/mywaterquality/](http://www.waterboards.ca.gov/mywaterquality/) under “*Are Our Aquatic Ecosystems Healthy?*”

The new *California Wetlands* portal includes interactive maps and monitoring data that focus on the location, extent and health of the state’s wetlands. The goal is to make this information as timely and user-friendly as possible.

Wetlands perform numerous functions and provide important services to society. They help control global warming by trapping carbon dioxide, improve flood control by storing flood waters, maintain water supplies by replenishing aquifers, protect water quality by filtering runoff, and provide essential habitat for fish and wildlife including threatened and endangered species as well as commercially important species. Wetlands are also attractive. They are an important component of the California landscape.

But many of California’s wetlands have been lost. Some regional studies have reported loss rates up to 90 percent. Remaining wetlands are threatened by human activities, including conversion to urban and agricultural uses, introduction of non-native species, pollution, and overharvesting.

The new *California Wetlands* portal brings this information together in a single location and in an easy to understand manner for the public, environmental organizations, and water quality professionals.

In 2006, the California legislature mandated coordination of water quality monitoring and assessment activities among organizations inside and outside California government, and that this information be made available to decision makers and the public via the internet. The Monitoring Council was formed in 2007 by a cooperative agreement between the California Environmental Protection Agency and the Natural Resources Agency for this purpose. In 2009, the Monitoring Council released its first two internet portals, *Is it Safe to Swim in Our Waters?* and *Is it Safe to Eat Fish and Shellfish from Our Waters?*

The Monitoring Council brings together water quality information from a variety of organizations with special expertise in wetland monitoring and assessment, coordinated through the California Wetland Monitoring Workgroup. Twenty-three state, federal, regional and local agencies and non-governmental organizations have pitched in to answer your water quality questions.
