## NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY
CONTROL PLAN FOR THE COLORADO RIVER BASIN REGION ESTABLISHING
TOTAL MAXIMUM DAILY LOADS AND IMPLEMENTATION PLAN FOR
PYRETHROID PESTICIDES IN ALAMO RIVER AND NEW RIVER,
IMPERIAL COUNTY

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Colorado River Basin Regional Water Quality Control Board's (Colorado River Basin Water Board) amendment to the Water Quality Control Plan for the Colorado River Basin Region (Basin Plan) establishing Total Maximum Daily Loads (TMDLs) and an Implementation Plan for Pyrethroid Pesticides in the Alamo River and the New River, Imperial County (collectively, Basin Plan Amendment).

Comment letters **must** be received by 12:00 noon on November 22, 2024. Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise.

**REQUIREMENTS FOR SUBMITTING COMMENTS** (23 Cal. Code Regs., § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

- 1. Comments must specifically address the final version of the Basin Plan amendment adopted by the Colorado River Basin Water Board.
- 2. If the Colorado River Basin Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Colorado River Basin Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Colorado River Basin Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Colorado River Basin Water Board.
