NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED NON-REGULATORY AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR THE LOS ANGELES REGION TO ADMINISTRATIVELY UPDATE CHAPTER 4 "STRATEGIC PLANNING AND IMPLEMENTATION" AND CHAPTER 5 "PLANS AND POLICIES"

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Los Angeles Regional Water Quality Control Board's (Los Angeles Water Board) amendments to the Water Quality Control Plan for the Los Angeles Region that would administratively update Chapter 4 "Strategic Planning and Implementation" and Chapter 5 "Plans and Policies" by incorporating updated information and tables. The Basin Plan amendments were adopted by the Los Angeles Water Board on June13, 2019 (R19-006) and are available for review at:

REQUIREMENTS FOR SUBMITTING COMMENTS (23 Cal. Code Regs., § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

- 1. Comments must specifically address the final version of the Basin Plan amendment adopted by the Los Angeles Water Board.
- 2. If the Los Angeles Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Los Angeles Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Los Angeles Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Los Angeles Water Board.
