PROPOSED APPROVAL OF AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR THE LOS ANGELES REGION TO REVISE THE IMPLEMENTATION SCHEDULES FOR MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) DISCHARGERS, INCLUDING CALTRANS, SUBJECT TO THE FOLLOWING TOTAL MAXIMUM DAILY LOADS (TMDLS) IN THE LOS ANGELES REGION:THE SANTA MONICA BAY BEACHES BACTERIA TMDL; THE MARINA DEL REY HARBOR MOTHERS' BEACH AND BACK BASINS BACTERIA TMDL; THE MALIBU CREEK AND LAGOON BACTERIA TMDL; THE MALIBU CREEK NUTRIENTS TMDL; THE MALIBU CREEK AND LAGOON SEDIMENTATION AND NUTRIENTS TMDL TO ADDRESS BENTHIC COMMUNITY IMPAIRMENTS; THE BALLONA CREEK ESTUARY TOXIC POLLUTANTS TMDL; THE MARINA DEL REY HARBOR TOXIC POLLUTANTS TMDL; THE BALLONA CREEK, BALLONA ESTUARY, AND SEPULVEDA CHANNEL BACTERIA TMDL; AND THE BALLONA CREEK METALS TMDL

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Los Angeles Regional Water Quality Control Board's (Los Angeles Water Board) amendments to the Water Quality Control Plan for the Los Angeles Region (Basin Plan) that would extend final TMDL Implementation deadlines for the above listed TMDLs in the Los Angeles Region. REQUIREMENTS FOR SUBMITTING COMMENTS (23 Cal. Code Regs., § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

- 1. Comments must specifically address the final version of the Basin Plan amendments adopted by the Los Angeles Water Board.
- 2. If the Los Angeles Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Los Angeles Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Los Angeles Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Los Angeles Water Board.
