## PROCEDURAL MATTERS

Because the proposed order contains both a Time Schedule Order issued pursuant to Water Code section 13300 and elements of a Cleanup and Abatement Order issued pursuant to Water Code section 13304, the State Water Board will accept relevant additional evidence beyond that contained in the administrative record provided by the Los Angeles Region. Any person submitting additional documentary evidence must submit the evidence in writing and must also provide it to AES and the Los Angeles Water Board by noon on Thursday, July 28, 2022, in accordance with California Code of Regulations, title 23, section 2050.6, subdivision (a)(3).

To ensure a productive and efficient Board hearing in which all participants have an opportunity to participate, oral statements and the presentation of any additional evidence may be time limited. Parties and interested persons proposing panels are encouraged to prepare panel presentations.
