NOTICE OF PUBLIC HEARING

TO CONSIDER AMENDING THE WATER QUALITY CONTROL PLAN REGARDING
ONSITE WASTEWATER SYSTEM IMPLEMENTATION PROGRAM

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board), will hold a public hearing on May 5, 2011, to hear comments and consider adoption of a resolution amending the *Water Quality Control Plan, Central Coast Basin* (Basin Plan) regarding the onsite wastewater system implementation program. Proposed Resolution No. R3-2011-0004 would amend the Basin Plan with clarifying detail to the amendments to the Basin Plan adopted on May 9, 2008, and March 19, 2009.

Copies of the proposed resolution, associated staff report, text of the proposed Basin Plan amendment, and other relevant documents are available on the Internet at <http://www.waterboards.ca.gov/centralcoast/Permits/Index.htm>. These documents are also available by request at the office of the Central Coast Water Board. Actions to amend the Basin Plan will be taken in accordance with a regulatory program exempt (under §21080.5 of the Public Resources Code) from the requirement to prepare an environmental impact report under the California Environmental Quality Act (Public Resources Code, §21000 et seq.) and with other applicable laws and regulations. At the conclusion of the hearing the Central Coast Water Board will consider approval of the proposed amendment to the Basin Plan.

Written comments and evidence regarding the proposed actions must be submitted no later than March 25, 2011. Written comments and evidence submitted after this date will not be accepted into the record, unless allowed by the Chair of the Central Coast Water Board. Comments and evidence received by this date will be considered in preparation of staff recommendations to the Central Coast Water Board. The Board will provide an opportunity for oral comments at the hearing. Time limits may be imposed. Please note that all exhibits, charts, graphs, and other testimony timely presented as evidence must be left with the Water Board as part of the administrative record. 
