**NOTICE OF PUBLIC HEARING
NOTICE OF FILING A DRAFT ENVIRONMENTAL DOCUMENT**

**To Consider Adoption of Resolution No. R3-2012-0002
Amending the Water Quality Control Plan for the Central Coast Basin to (1) Adopt
the Total Maximum Daily Loads for Fecal Indicator Bacteria in the Santa Maria
River Watershed and (2) Add the Santa Maria River Watershed (including Oso
Flaco Creek subwatershed) to the Domestic Animal Waste Discharge Prohibition**

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board Central Coast Region (Central Coast Water Board) will hold a public hearing to consider adoption of a resolution amending the Water Quality Control Plan (Basin Plan) for the Central Coast Basin. The Basin Plan establishes measures to protect beneficial uses of waters of the state and achieve water quality objectives.

If accepted, the resolution will amend the Basin Plan by adding the Santa Maria River Watershed (including Oso Flaco Creek subwatershed) as subject to the Domestic Animal Waste Discharge Prohibition, and incorporating Total Maximum Daily Loads (TMDLs) for Fecal Indicator Bacteria in Santa Maria River Watershed, including Alamo Creek, Blosser Channel, Bradley Canyon Creek, Bradley Channel, Cuyama River, La Brea Creek, Little Oso Flaco Creek, Main Street Canal, Nipomo Creek, Orcutt Creek, Oso Flaco Creek, Oso Flaco Lake, Santa Maria River Estuary and the Santa Maria River.

At the conclusion of the hearing the Central Coast Water Board will consider approval of the proposed resolution.

Actions to amend the Basin Plan by the Central Coast Water Board will be taken in accordance with a regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California Environmental Quality Act (Public Resources Code, section 21000 et seq.) and with other applicable laws and regulations.

Interested persons may submit written comments on the proposed amendments and substitute environmental documents and may make oral comments at the hearing. The written public comment period will occur from **November 1, 2011, to December 15, 2011**. All written comments must be submitted to Shanta Keeling of the Central Coast Water Board **by 5:00 p.m. on December 15, 2011**, at the address listed above or electronically to skeeling@waterboards.ca.gov. Staff will respond in writing to written comments submitted by December 15, 2011. Staff may not respond in writing to comments submitted after that date.

Your timely submittal will allow staff and the Central Coast Water Board members to consider your comments before taking final action at the meeting to be held on March 15, 2012.

Time limits may be imposed on oral presentations at the hearing. At the conclusion of the public hearing, the Central Coast Water Board will consider certification of the substitute environmental documents and approval of the proposed amendments. The Central Coast Water Board may close the public hearing and the comment period, but consider adoption of the amendments at a later public hearing.
