TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—LONG BEACH WATER DEPARTMENT

1. NORTH LONG BEACH 12 WELL, 4505 CHEERY AVENUE, LONG BEACH, CALIFORNIA (NPDES NO. CAG994005, CI-10057)
2. EL DORADO PARK WISE WELL 1A, 7010 EAST SPRING STREET, LONG BEACH, CALIFORNIA (NPDES NO. CAG994005, CI-9987)
3. HEARTWELL GOLF COURSE COMMISSION WELL 17, HACKETT AVENUE AND EAST PARKCREST STREET, LONG BEACH, CALIFORNIA (NPDES NO. CAG994005, CI-9988)

The subject discharges are regulated under Order No. R4-2003-0108, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.

On November 18, 2014 the State Water Resources Control Board (State Water Board) adopted the Statewide National Pollutant Discharge Elimination System (NPDES) Permit to regulate Drinking Water Systems Discharges to Waters of the United States (Order WQ 2014-0194-DWQ, General Order NO. CAG140001. The Order provides regulatory coverage for short-term or seasonal planned and emergency (unplanned) discharges resulting from a water purveyor's essential operations and maintenance activities undertaken to comply with the federal Safe Drinking Water Act, the California Health and Safety Code, and the State Water Board's Division of Drinking Water permitting requirements for providing reliable delivery of safe drinking water. The order became effective on February 26, 2015.

On August 10, 2015, City of Long Beach submitted a completed application package to State Water Board for coverage under the Statewide Drinking Water Systems Discharge Permit. On March 23, 2016, the State Water Board issued a Notice of Applicability to City of Long Beach Water System for coverage under the Statewide Drinking Water Systems Discharge Permit. Therefore, coverages for City of Long Beach's North Long Beach Well 12 (WDID-4B197600139, CI-10057), El Dorado Park Wise Well 1A (WDID-4B197600133, CI-9987), and Heartwell Golf Course Commission Well 17 (WDID-4B197600139, CI-9988) under the Regional Water Board
