**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—ZONE MUTUAL WATER COMPANY—WELL NO. 21, 6648 LOS ANGELES AVENUE, SOMIS, CALIFORNIA (NPDES NO. CAG994005, CI—10095)**

Dear Ms. Schoen:

In our letter dated October 13, 2014, we informed you that the subject discharge is regulated under Order No. R4-2003-0108, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.

We have reviewed your February 23, 2016, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that no groundwater discharge occurred since December 2014 at the above-referenced facility and that the subject NPDES permit is no longer needed. Since the NPDES permit is no longer necessary, your coverage under the Board Order No. R4-2003-00108, General NPDES Permit No. CAG994005, CI-10095 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of hydrostatic test water to surface water or land becomes necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters or land.
