TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT-ZIAD GHANDOUR, ZIAD GHANDOUR SANTA MONICA, 547 PALISADES BEACH ROAD, SANTA MONICA, CALIFORNIA (NPDES NO. CAG994004, CI-10226)

Dear Mr. Ghandour:

In our letter dated April 28, 2016, we informed you that the subject discharge is regulated under Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Water in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Boards on June 6, 2013.

We have reviewed your February 12, 2018, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that the construction dewatering project was completed on October 31, 2017, and that the subject NPDES permit is no longer needed.

On May 30, 2018, Board staff inspected the project site and verified that there is no discharge of groundwater from the project site to the storm drain. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2013-0095, General NPDES Permit No. CAG994004, CI-10226 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of wastewater to surface water or land becomes necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters or land.
