TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—5601-5567 SANTA MONICA BLVD (LA) OWNER, LLC—5567 SANTA MONICA BOULEVARD, 5601 TO 5567 SANTA MONICA BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI—10291)

Dear Mr. Kuba:

In our letter dated February 7, 2017, we informed you that the subject discharge is regulated under Order No. Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 6, 2013.

We have reviewed your January 10, 2019, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that the proposed construction project was cancelled, and that the subject NPDES permit is no longer needed. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2013-0095, General NPDES Permit No. CAG994004, CI-10291 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of wastewater to surface water or land becomes necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters or land.


