TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS FOR STATEWIDE GENERAL WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES TO LAND WITH A LOW THREAT TO WATER QUALITY – MALIBU DEWATERING PROJECT ALONG CROSS CREEK ROAD, CIVIC CENTER WAY, AND WEBB WAY, MALIBU, CA (FILE NO. 17-040, ORDER NO. 2003-0003-DWQ, CI NO. 10315, SERIES NO. 030, GEOTRACKER GLOBAL ID-100039667)

Dear Mr. Brager:

Our letter dated May 24, 2017, informed you that the City of Malibu's (City's) Dewatering Project along Cross Creek Road, Civic Center Way, and Webb Way (Dewatering Project) is regulated under Order No. 2003-0003-DWQ, which specifies your Waste Discharge Requirements.

The dewatering activities for groundwater seepage were conducted by the City between April 3, 2017 and September 21, 2017. The quantity of dewatering was up to 120,000 gallons per day (GPD). The groundwater seepage collected at four bore pits and open trench along Cross Creek Road was discharged to five discharge points that provide an initial desilting treatment, then it flowed to Legacy Park Pond by gravity. Once the water reached Legacy Park Pond, it was further treated by City's existing Storm Water Treatment Plant. The existing Storm Water Treatment Plant provides activated carbon filtration and ozone disinfection. The Legacy Park includes approximately 12 planted acres and a 4-acre pond. The City used treated groundwater seepage up to 120,000 GPD to irrigate the Legacy Park.

The City has not had any further dewatering since September 22, 2017. On May 1, 2018, we received your termination request letter for this Dewatering Project. Since the Dewatering Project had been completed and no more dewatering is anticipated, the coverage under Order No. 2003-0003-DWQ, File No. 17-040, and CI-10315 is no longer needed, and therefore is hereby terminated.
