**TRANSMITTAL OF ADOPTED WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR THE JOINT OUTFALL SYSTEM, LOS COYOTES WATER RECLAMATION PLANT (LOS COYOTES WRP), CERRITOS, CA (NPDES PERMIT NUMBER CA0054011, CI-5059)**
