ORDER No. R4-2002-0089

RESCINDING WASTE DISCHARGE REQUIREMENTS  
AND  
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMITS  
FOR DISCHARGES IN THE LOS ANGELES REGION

The California Regional Water Quality Control Board, Los Angeles Region, finds:

1. This Regional Board adopted waste discharge requirement for discharges to surface waters which also serve as National Pollutant Discharge Elimination System (NPDES) permit for Discharger listed below.
2. This discharger has been enrolled under a NPDES permit or has eliminated their discharges to surface waters.
3. Therefore, the following waste discharge requirements and NPDES permits are no longer necessary and should be rescinded.
4. The following order is hereby rescinded, except for enforcement purposes.
5. The rescission of waste discharge requirements is exempt from the provisions of Chapter 3 (commencing with Section 21100), Division 13, Public Resources Code, in accordance with Water Code Section 13389.

The Regional Board has notified the Discharger and interested agencies and persons of its intent to consider rescission of the following waste discharge requirements and has provided them with an opportunity to submit their written views and recommendations.

The Regional Board, in a public hearing, heard and considered all comments and testimony pertinent to the matter.

IT IS HEREBY ORDERED that the following waste discharge requirements and NPDES permits be rescinded:

SUBJECT: WASTE DISCHARGE REQUIREMENTS (NPDES PERMIT  
RESCISSION)

DISCUSSION: In accordance with the Federal Clean Water Act, as amended, all waste discharges to navigable waterways, or tributaries thereto, require National Pollutant Discharge Elimination System (NPDES) permits.

This Board adopted an NPDES permit for Anacapa Marine Services and Hitco Carbon Composites (Order Nos. 96-016 and 01-041 respectively); the discharger has been found to no longer need a permit and has been field checked and verified by staff. Therefore, these permits should be rescinded.

A tentative order has been prepared which proposes to rescind Order Nos. 96-016 and 01-041.

RECOMMENDATION: Adopt the tentative order.
