**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—WELLS FARGO BANK, GARLAND CENTER, 1200 W. 7TH STREET, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994003, CI-6641)**


Dear Mr. Barkho:

The subject discharge is regulated under Order No. R4-2009-0047, *Waste Discharge Requirements for Discharges of Nonprocess Waste Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on April 2, 2009. On June 8, 2015, you submitted a Notice of Intent (NOI) form to continue discharge under this general NPDES permit.

We have reviewed the NOI form. The water quality data included with the NOI form indicates elevated perchlorate level. Perchlorate is not regulated under the existing general NPDES permit. Therefore, the existing General NPDES permit No. CAG994003 is no longer appropriate to regulate the wastewater discharge from the facility. The wastewater discharge is more appropriately regulated under Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 6, 2013. Enrollment of the subject discharge under Order No. R4-2013-0095 has been authorized in a separate correspondence. This letter terminates your enrollment under Order No. R4-2009-0047, except for enforcement purposes.
