TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – B. C. Plaza, 711 N. BROADWAY, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994003, CI-6885)

In our letter dated April 21, 1999, we informed you that the subject discharge is regulated under *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Nonprocess Wastewaters Not Requiring Treatment Systems to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On June 9, 2004, you submitted a Notice of Intent (NOI) form and analytical results of groundwater samples to continue enrollment under the General NPDES Permit. Based on the information provided, Board staff have determined that your discharge is more appropriately regulated under NPDES Permit No. CAG994004 (Order No. R4-2003-0111), which was adopted by this Board on August 7, 2003.

On January 13, 2005, NPDES Permit No. CAG994004, Order No. R4-2003-0111, and a revised Monitoring & Reporting Program (No. CI-6885) were issued to you to discharge groundwater seepage from the subject facility to the storm drain. Since the existing discharge permit has been superseded by Order No. R4-2003-0111, coverage under NPDES Permit No. CAG994003 (Order No. 98-055) is hereby terminated, except for enforcement purposes.
