TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS — CONOCOPHILLIPS CO., UNOCAL, 10389 SANTA MONICA BLVD., LOS ANGELES, CA (NPDES No. CAG834001, CI-6897)

Dear Mr. Mosconi;

In our letter dated April 18, 2014, we informed you that the subject discharge is regulated under, *General National Pollutant Discharge Elimination System (NPDES) and Waste Discharge Requirements for Discharges of Treated Groundwater and other Wastewaters from Investigation and/or Cleanup of Petroleum Fuel Contaminated Sites to Surface Waters (Order No. R4-2013-0042)*, adopted by this Board on March 7, 2013.


We have reviewed your May 13, 2016, letter which requested termination of your coverage under the general NPDES permit, Order No. R4-2013-0042. The letter indicated the general permit is no longer needed as the operation of the treatment system has stopped. The treatment system and its enclosure were decommissioned and removed from the site in February 2016.

On September 27, 2016, Board staff inspected the project site and verified that there is no discharge of groundwater from the project site to the storm drain. Since there is no discharge of groundwater from the site, coverage under Board Order R4-2013-0042, General NPDES Permit No. CAG834001, CI-6897 for the facility is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
