**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—EQUITY OFFICE PROPERTIES, 5550 TOPANGA CANYON, WOODLAND HILLS, CALIFORNIA (NPDES NO. CAG994004, CI-6917)**

The subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on July 8, 2008.


We have reviewed your December 7, 2011, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you have obtained a permit from City of Los Angeles to discharge groundwater to sanitary sewer system and ceased the groundwater discharge to storm drain.

On February 22, 2012, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to the storm drain. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2008-0032, General NPDES Permit No. CAG994004, for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
