TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—ERIC REALTY INC., 16055 HERON AVENUE, LA MIRADA, CALIFORNIA (NPDES NO. CAG914001, CI—7798)

In our letter dated September 5, 2002, we informed you that the subject discharge is regulated under Order No. R4-2002-0107, *General NPDES and Waste Discharge Requirements for Treated Groundwater Discharges from Investigation and/or Cleanup Volatile Organic Compounds Contaminated-Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On June 5, 2007, you informed the Regional Board staff that you have applied for coverage under the Waste Discharge Requirements for your facility discharge. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On July 27, 2007, our staff inspected the facility and verified that there is no discharge to the storm drain.

Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2002-0107 for the subject facility is hereby terminated except for enforcement purposes. If you have any questions, please contact Vilma Correa at (213) 576-6794.
