CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – SOUTHERN CALIFORNIA WATER COMPANY, ENCINITA WATER TREATMENT PLANT, 4836 NORTH ENCINITA AVENUE, TEMPLE CITY, CALIFORNIA (NPDES NO. CAG994003, CI-8065)

We have completed our review of your Notice of Intent (NOI) and analytical results of representative wastewater samples in order to continue enrollment under the General NPDES Permit. Discharge of filter backwash wastewater generated from drinking water treatment at the above-referenced facility is currently regulated under NPDES General Permit No. CAG994003 (Order No. 98-055) adopted by this Board on June 29, 1998.

Based on the information provided, we have determined that discharge of filter backwash wastewater meets the conditions to be regulated under Order No. R4-2004-0058, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Nonprocess Wastewater to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on April 1, 2004. Your existing enrollment under NPDES Permit No. CAG994003, Order No. 98-055, which was issued to you on August 19, 1999, is superseded by this new permit that terminated your coverage under Order No. 98-055.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2004-0058 and revised Monitoring and Reporting Program No. CI-8065. Prior to starting discharge, a representative sample of the effluent shall be obtained and analyzed to determine compliance with the discharge limitations. The discharge limitations in Part E.i. of Order No. R4-2004-0058 are applicable to your discharge. The wastewater discharge flows into Eaton Wash, thence to Rio Hondo (upstream of Whittier Narrows Flood Control Basin). Therefore, the discharge limitations in Attachment B.7.g. are applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8065 and NPDES No. CAG994003", which will assure that the reports are directed to the
