TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—UNIVAR USA INC., FORMER VOPAK USA INC. FACILITY, 4256 NOAKES STREET, COMMERCE, CALIFORNIA (NPDES NO. CAG914001, CI—8315)

Dear Mr. Sylvester:

In our letter dated August 15, 2007, we informed you that the subject discharge is regulated under Order No. R4-2007-0022, *General NPDES and Waste Discharge Requirements for Discharges Treated Groundwater From Investigation and/or Cleanup of Volatile Organic Compounds Contaminated-Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On February 13, 2012, you informed Regional Board staff that the discharge from the above-referenced facility has been diverted to the sanitary sewer. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. Regional Board staff inspected the facility and verified that there is no discharge to the stormdrain. Since there is no discharge from the site to the stormdrain, coverage under Board Order No. R4-2007-0022 for the subject facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
