TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – HARRY'S AUTO BODY INC., 1023 AND 1027 S. REDONDO BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994002, CI-8331)

In our letter dated November 28, 2001, we determined that the subject discharge is regulated under Order No. 97-043, *General NPDES and Waste Discharge Requirements for Discharges of Treated Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

We have received and reviewed your letter dated August 12, 2004, submitted by EP Associates, informing the Regional Board that your discharge of groundwater has ceased at the above-referenced site. Therefore, the NPDES permit is no longer needed. On August 30, 2004, Board staff inspected the site and verified that there is no discharge of groundwater to the storm drain. Since there is no discharge, coverage under Board Order No. 97-043 for the subject site is hereby terminated except for enforcement purposes.
