GENERAL WASTE DISCHARGE REQUIREMENTS FOR SMALL COMMERCIAL AND MULTIFAMILY RESIDENTIAL SUBSURFACE SEWAGE DISPOSAL SYSTEMS – NEW DORMITORY, MASTER’S COLLEGE, 21726 PLACERITA CANYON ROAD, SANTA CLARITA, CA 91321 (FILE NO. 02-037, CI-8429)

We have completed our review of your application for Waste Discharge Requirements for the wastewater discharge from the new dormitory to a septic disposal system located on campus grounds in Placerita Canyon in the City of Santa Clarita. The disposal system will include three septic tanks for a total capacity of 14,000 gallons.

Regional Board staff have reviewed the information provided and have determined that the proposed discharge meets the conditions specified in Order No. 01-031, "General Waste Discharge Requirements for Small Commercial and Multifamily Residential Subsurface Sewage Disposal Systems," adopted by this Regional Board on February 22, 2001. Refer to the attached Fact Sheet.

Enclosed are your Waste Discharge Requirements, consisting of Order No. 01-031 and Monitoring and Reporting Program No. CI-8429. Please note that the discharge limits in Attachment A of Order No. 01-031 are applicable to your discharge. The new dormitory and the five existing dormitories are scheduled for connection to a municipal sewer (the new Backbone Sewer Project for the Placerita Canyon) by September 30, 2004. As you know, a groundwater monitoring program was prepared by your consultant (Earth Systems of Southern California), and modified by Regional Board staff to include the installation of five groundwater monitoring wells, is held in abeyance provided Master's College adheres to the sewer connection schedule submitted July 12, 2002. Should the College fail to meet the sewer connection schedule for any reason, you will be required to fully implement the groundwater monitoring program described in the attached Monitoring and Reporting Program (MRP) CI No. 8429. In addition, should any changes be made to the proposed septic disposal system for the new dormitory, revised engineering drawings must be filed with the Regional Board within 30 days.

The "Monitoring and Reporting Program" requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit.

When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8429", which will assure that the reports
