TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—CEDARS SINAI MEDICAL CENTER—NORTH CARE TOWER CENTER PROJECT, 8700 BEVERLY BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI—8481)

Dear Mr. Kennedy:

In our letter dated February 5, 2016, we informed you that the subject discharge is regulated under Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 6, 2013.


On July 5, 2017, you informed Regional Board staff that the discharge from the above-referenced facility has been diverted to the sanitary sewer and the subject NPDES permit is no longer needed. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit.

On July 17, 2017, Board staff inspected the project site and verified that there is no discharge of groundwater from the project site to the storm drain. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2013-0095, General NPDES Permit No. CAG994004, CI-8481 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land becomes necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters or land.
