Dear Ms. Walker:


In our letter dated September 8, 2005, we informed you that the subject discharge is regulated under Order No. R4-2004-0109, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on July 1, 2004, which also serves as your NPDES permit.

We have reviewed your October 23, 2006, letter which requested termination of your coverage under the General Permit. The letter indicated that the above-referenced project has been completed.

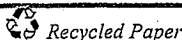
On January 29, 2008, Board staff inspected the project site and verified that there is no discharge of groundwater from the site to surface waters. Since there is no discharge of groundwater from the site to surface waters, coverage under the Board Order No. R4-2004-0109, General NPDES Permit No. CAG674001, for the subject site is hereby terminated except for enforcement purposes.

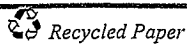
