COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – CALLEGUAS MUNICIPAL WATER DISTRICT, OXNARD PLAIN BRINE LINE PHASE 1B PROJECT, ALONG HUENEME ROAD, BETWEEN RICE AVENUE AND LAS POSAS ROAD, OXNARD (CAG674001, CI-8979)

We have completed our review of your application for a permit to discharge waste under the National Pollutant Discharge Elimination System (NPDES).

Based on the attached Fact Sheet and other information provided, the proposed discharge of hydrostatic test water meets the conditions to be regulated under Order No. R4-2004-0109, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on July 1, 2004.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2004-0109 and Monitoring and Reporting Program No. CI-8979. Prior to starting discharge, a representative sample of the effluent must be obtained and analyzed to determine compliance with the discharge limitations. The discharge limits in Part E of Order No. R4-2004-0109 are applicable to your discharge. The wastewater flows into Revolon Slough, thence into the Calleguas Creek (below Potrero Road). Therefore, the discharge limitations in Attachment B are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8979 and NPDES No. CAG674001", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
