TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—100 EAST OCEAN PARTNERS LLC—EDGEWATER ON OCEAN CONDOMINIUM PROJECT, 100 OCEAN BOULEVARD, LONG BEACH, CALIFORNIA (NPDES NO. CAG994004, CI-9024)

In our letter dated February 7, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.


We have received and reviewed your October 27, 2008 letter, requesting termination of your coverage under the General Permit. The letter indicated that the construction project did not occur at the subject project site as proposed. Therefore, the subject general permit is no longer needed.

On December 23, 2008, Board staff inspected the project site and verified that there is no discharge of groundwater from the subject property site to the storm drain. Since there is no discharge of groundwater from the site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject project is hereby terminated except for enforcement purposes.

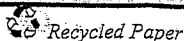
Please note that if future discharge of any groundwater to surface water becomes necessary at the site, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
