TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—IRVING & PHYLLIS KERN TRUST, INTERNATIONAL GARMENT FINISH INC., 2144 GARLORD STREET, LONG BEACH, CALIFORNIA (NPDES NO. CAG994004, CI-9218)

Dear Mr. Chakmak:


In our letter dated January 10, 2007, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have reviewed your consultant's October 27, 2008, letter requesting termination of your coverage under the General Permit. The letter indicated that construction project and the accompanying dewatering activities at the above-referenced site has been completed.

On January 16, 2009, Board staff inspected the site and verified that there is no discharge of groundwater from the site to surface waters. Since there is no discharge of groundwater from the site to surface waters, coverage under the Board Order No. R4-2003-0111, General NPDES Permit No. CAG994001, for the subject site is hereby terminated except for enforcement purposes.

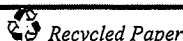
